(i) **NATIONALITY** : Candidate must be a citizen of India.

- iv.** SSLC/SSC/ISC Marks card will be considered as proof of date of birth.
- v.** Candidates seeking age relaxation will be required to enclose copy of necessary certificate (s) along with application and submit in original at the time of interview and at any subsequent stage of the process for verification.
- vi.** EWS/OBC/SC/ST /Disability Certificate should be strictly in the format available on the BEL website and issued on or after 01.12.2023 failing which, candidates will be considered under 'General' category, provided they are otherwise meeting all other criteria stipulated for General Candidates.
- vii.** The application of the candidates not meeting the prescribed age criteria will be rejected/cancelled without any prior intimation.
- viii.** For Candidates belonging to Persons with Benchmark Disability (PwBD) category having minimum 40% disability will get 10 (ten) years relaxation in addition to the relaxation applicable to SC/ST/OBC mentioned above.

II EDUCATIONAL QUALIFICATION AND AGE:

- **Project Engineer-I:** BE/B. Tech in any Engineering Discipline with PASS CLASS from a recognised University /Institution in the relevant discipline. The upper age limit for General category shall be **32 years**. Age relaxation for SC/ST/OBC-NCL/PwBD candidates will be as per the prevailing Government guidelines.
- **Trainee Engineer-I:** BE/B. Tech/B.Sc Engg. (4-year course) in CS/IS/IT with PASS CLASS from a recognised University /Institution in the relevant discipline. The upper age limit for General category shall be **28 years**. Age relaxation for SC/ST/OBC-NCL/PwBD candidates will be as per the prevailing Government guidelines.
- **Candidates must possess all years/semesters mark sheets and Provisional/Final Degree certificate. (In case of CGPA grading, candidates have to compulsorily provide certificate regarding CGPA conversion to percentage of marks as per the guidelines provided by the concerned University, to substantiate their claim. Applications without the conversion certificate will be rejected and will result in disqualification.)**

III MODE OF SELECTION:

Project Engineer-I: Selection will be through Written Test followed by Interview for shortlisted candidates. The details regarding selection date and venue will be e-mailed to the candidates/applicants through email to the mail id provided by the candidate. Candidates are required to comply with the instructions indicated therein.

- Candidates meeting the specified criteria as mentioned above in the advertisement will be communicated to attend the Written Test for 85 marks.
- Candidates will be shortlisted for interview in the order of merit based on the performance in the written test, in the ratio 1:5. Interview will be conducted subsequently, for 15 marks.
- The results of the final selection will be available on BEL website.

Trainee Engineer-I: Selection will be through Written Test and candidates will be selected in the order of merit i.e , Category-wise, Discipline-wise. The written test will be conducted for 100 marks. The details regarding selection date and venue will be e-mailed to the candidates/applicants through email to the mail id provided by the candidate. Candidates are required to comply with the instructions indicated therein.

- Candidates meeting the specified criteria as mentioned above in the advertisement will be communicated to attend the Written Test.
- The results of the final selection will be available on BEL website.

IV JOB REQUIREMENT/EXPERIENCE:

Project Engineer-I: Candidates with minimum two years relevant experience in Software/IT and skill set as specified in the advertisement only are eligible to apply.

- a. Candidate possessing the requisite number of years of hands-on Post Qualification Industrial Experience in the relevant area only need to apply.
- b. The cut-off date for deciding the maximum permissible experience (Post-Qualification Experience) shall be 01.12.2024. In order to compute post-qualification work experience, the period of work experience starting from the month immediately succeeding the month of final examination in which candidate acquired the essential qualification shall be considered.
- c. **Academy/Teaching experience or/and training/research work acquired, online work experience/ experience in non-profit Organization, Internship/Project Work placements which are part of Academic curriculum will not be considered as relevant experience.**
- d. Candidate should possess Experience certificates/Documents issued by the previous and present employer clearly indicating period of employment and post held.
- e. Candidates are required to enclose a separate write up describing the relevant post qualification experience gained/held by them.
- f. The decision of the Selection Committee with respect to relevance of Industrial Experience will be final. Work Experience indicated without supporting Documents will not be considered and is liable to be rejected/cancelled without any prior intimation.

Trainee Engineer-I: Software Development, Testing & IT Support and Maintenance - 0 to 1 year relevant post qualification experience in Software field (Freshers can apply).

V TERMS OF ENGAGEMENT

Project Engineer-I: Selected candidate will be engaged initially for a period of 3 years. The tenure is extendable by 1 year (maximum tenure of 4 years including the initial engagement) based on project requirement and performance of the candidate.

Retention Bonus: Candidates who join as Project Engineer-I and complete overall tenure of 4 years will be entitled for Retention Bonus of Rs. 25,000/- for every completed year. However, the retention bonus will be payable at the end of 4 years i.e., Rs. 1,00,000/-.

Trainee Engineer-I: will be engaged initially for a period of 2 years extendable by 1 year (maximum tenure 3 years including the initial engagement) based on project requirement and performance of the candidate.

Trainee Engineer who has completed tenure of 2 years within BEL as Trainee Engineer will be considered for Advancement to Project Engineer-I in the same Unit/SBU/R&D office subject to fulfilling the following criteria:

- * Performance assessment scores as a Trainee Engineer should meet the criteria of 80% & above marks for both years (aggregate);
- * Attendance (>80% during preceding 1 year) and General discipline must be good;
- * Trainee Engineer must not have any adverse remarks against him / her in the preceding 2 years

Post advancement to Project Engineer-I, the engagement will be for a period of 3 years which may be extended upto a maximum of One Year based on project requirement and performance of the Project Engineer with due approval of the competent authority.

After advancement to Project Engineer the Engineer will be eligible for Retention Bonus of Rs. 1,00,000/- (One Lakh) on completion of tenure as Project Engineer (4 years).

VI APPLICATION FEE:

- a.
