**Note:-** #Manager (Civil): Total Vacancies 11 nos and 3 vacancies are specifically reserved for Divyangjan candidates (as mentioned above). 1 no. vacancy in the Unreserved (UR) category. **Accommodation Process**: Divyangjan candidates will be accommodated in the vacancies available in the categories (UR, OBC, SC, ST, EWS) that they belong to. For example: If a Divyangjan candidate belongs to the UR/OBC/SC/ST category, and there is a vacant post in the UR/OBC/SC/ST category, they will be allocated that vacancy. Essentially, disabled candidates will be accommodated based on their category and the available vacancies in those categories.

# 1. HOW TO APPLY

Candidates who wish to apply for Manager (Civil/Arch./Design/Elec.) position in MPBDC for the year 2024. Must have passed engineering B.E./B.Tech./B.Arch./Electrical with minimum 60% from AICTE approved institution.

- Ø Must have qualified in Graduate Aptitude Test of Engineering in any one year of GATE-2022/GATE-2023/GATE-2024.
  - Ø The scores obtained in **any one year of GATE-2022/GATE-2023/GATE-2024** in Civil Engineering Paper will be utilized for selection of Manager (Civil/Arch./Design/Elec.).
  - Ø Valid GATE Registration Number & score card is necessary for applying for this position.
  - Ø Candidates will have to individually apply through MP Online website only. The website www.mponline.gov.in will be activated from **31-12-2024** (as informed by the MP Online)

- b) All candidates are required to make a payment of Rs. 250+18%(GST)= 295/- as processing fee.
- c) On submission of online application, the system will generate an Acknowledgement Slip having a unique Acknowledgement No.
- d) Age limit: Minimum age limit is 21 years.

Candidate's age as on **01.01.2025** shall not be more than 35 years.

Candidates are advised to go through this website for qualifications required, age limits and other pertinent details and follow the directions given for applying for the position of Manager (Civil/Arch./Design/Elec.) in MPBDC.

# 3. RESERVATION & RELAXATION

- a) Upper age limit is relaxable as under: -
  - Ø SC/ST/OBC by 5 years.
  - Ø Physically Challenged by 15 years for SC/ST Category.
- b) Candidates applying under reserved category must be domicile of M.P.
- c) Relaxation in age for Ex-Servicemen will be as per extant Govt. rules.
- d) Upper age limit is relaxable by 5 years for the candidates who had ordinarily been domiciled in the state of Jammu & Kashmir during the period from 1/1/1980 to 31/12/1989.
- e) Reservations & Relaxation as per M.P. Government rules.

### 4. SELECTION PROCESS

Merit list will be prepared based on any one year of GATE-2022/GATE-2023/GATE-2024.

The candidates should have obtained B.E/B. Tech Civil Engineering/Architecture/Electrical Degree from an AICTE approved institute with minimum 60% marks for Unreserved/OBC Candidates.

**Document Verification Deadline**: After the selection order is issued, the candidate is given a 15-day time limit to get their documents verified.

**Failure to Verify Documents**: If the candidate does not complete the document verification within the specified time limit (or does not notify the Corporation in advance), the Corporation will presume that the candidate is not willing to join.

**Cancellation of Selection**: In this case, the selection order will be cancelled automatically. The next eligible candidate on the merit list (based on their GATE score) will then be issued a new selection order for document verification and selection.

In case selected candidates do not join as mentioned in the selection order or get disqualified due to any reason, the candidates lower in the order of merit list may be taken into consideration.

<u>Note:-</u> In case more than 01 candidates have equal **GATE-2022/GATE-2023/GATE-2024** score, the candidate with higher age will be selected.

before joining. Candidates should have sound health which will be assessed by Medical Board of Govt. of MP and the appointment will be subject to meeting the health standards prescribed by the Corporation.

For Physically Challenged candidates the definition of Disability will be as per 'The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995'.

The Physically Challenged candidates are required to furnish duly stamped Medical Certificate in relation to their disability from Government Hospital or Medical Board attached to Special Employment Exchange for the handicap (Refer to Benchmark Disabilities of MP Rights of Persons with Disabilities Rules, 2017).

### 6. TRAINING & EMOLUMENTS

Candidates joining MPBDC as Manager (Civil/Archi./Design/Elec.) will undergo probation for two years in the pay scale of Rs. 56100-177500 (Level-12). After successful completion of probation period of 02 years, the candidates will be absorbed as Manager (Civil/Arch./Design/Elec.) on pay scale of RS. 56100-177500 (Level-12)

# 7. SERVICE AGREEMENT BOND

Candidates are required to submit a surely bond amounting to Rs. 1,00,000 (Rupees One Lakh) in the form of Fixed Deposit (FD) in favour of Managing Director, Madhya Pradesh Building Development Corporation Limited executed by a Self/Parents for the locking period of 3 years.

It would be mandatory to join the appointed place within a period of 15 days from the issue of appointment order, otherwise the appointment will automatically be considered terminated.

The Rules of Madhya Pradesh Civil Services (Conduct) Rules 1965 will be applicable from the appointment. If conduct contrary to the above rules, action will be taken to service as per the prescribed procedure.

No request for transfer or change in place of posting shall be entertained for the first three years of service including the training period, unless transferred by the Corporation in administrative reasons. In case any outside influence is brought upon any superior authority in this matter, it will be construed as a misconduct as per M.P. Civil Services (Classification, Control and Appeal) Rules 1966.
