**Terms & Conditions for the Different Contractual Posts to be appointed in
Metropolitan Surveillance Unit, Bhopal on contract basis**

1. Candidate must fill Google form, they will get response copy on their email ID. Candidate must submit physical copy of filled form with self-attested copies of Educational & experience certificates to the office, those only are considered valid and those received by post or by any other medium at the concerned office within given time will be considered valid. Also note that Bhopal Municipal Corporation has not given the right to any person or any other organization to sell or accept applications.
2. The selection weightage will be based on the following-

3. For the position mentioned at serial no 1,2,3,4 &7 – The Candidates' selection will be based on the sequence of essential qualification mentioned in the above table. Preference will be given to the higher qualification candidates. The selection of candidates will be on merit basis prepared on the basis of above criteria.
(For example: If candidates are shortlisted for each qualification type for Senior public Health Specialist, the final selection will be made from first qualification type. If no selection is made from first qualification type, then selection will be made from second qualification type and so on.)
4. Candidate shall bear the experience which is corresponding to the post applied for (For details - see Annexure -I).
5. Candidate shall bear the prescribed qualification for selected posts (For details see Annexure -I).
6. Candidates having higher qualifications will get the preference.
7. In terms of experience, private and government experience will be considered. **(Government sector experience will be preferred over the private sector experience).**
8. Authenticated and valid experience certificates will only be considered.
9. Candidate appointed on contract basis will not be able to claim the regular service of the corporation.
10. The candidate, if selected will have to submit contract agreement on bond paper of Rs.100/- to Rs.500/-in Bhopal Municipal Corporation (BMC) format.
11. Candidate will not be given any other kind of allowance except applicable fixed remuneration.
12. The contract is for initially till 31st March 2026 from the date of appointment and will be continued depending on the approval of funds and the performance of the candidate.
13. No administrative or financial rights of Bhopal Municipal Corporation (BMC) will be granted to selected candidates during the contract period.
14. If the work of a contractual candidate is unsatisfactory during the contract period, the appointment of such candidates on contract basis will be terminated without any prior notice.
15. Candidates must ensure that they fulfill all the qualifications and conditions of the post applied for.
16. Candidates will be disqualified at any point in time if they are found to be not fulfilling the prescribed qualifications and conditions.
17. Correspondence address & contact details should be clear and complete.
18. Selected candidates should be present in person for document verification of Certificates of Educational Qualification, Professional Qualifications, Marksheets, Certificate of Experience. (Original copies and attested Xerox copies.)
19. Candidates must be present at the place of selection at their own cost. No travelling allowance is given to candidate by BMC.
20. Candidates will be disqualified if they are found to have submitted incorrect information / certificates / documents or withheld any information at any time after the commencement of selection process or appointment. Also, if the appointment is made, their contract appointment will be terminated without any prior notice.
21. The Madhya Pradesh Municipal Corporations (Appointment and conditions of service of Officers and Servants) Rules 2000 will not be applicable to the selected candidate after appointment.
22. The administration reserves the right to terminate the services of candidates appointed on contract basis without prior notice.
23. As the service of the candidates working during the contract period is temporary, their service will not be considered for seniority, or the service will not be given priority for seniority.
24. If a candidate attempts to exert pressure at any stage of recruitment or is found to have resorted to improper means or to arrange for imposters, he will be disqualified from the selection.

25. Candidates are advised to beware of the promise of getting a job through a person who pretends to be a mediator for Bhopal Municipal Corporation (BMC).
26. The Bhopal Municipal Commissioner has the power to stop the contractual recruitment process at any time or at any stage for administrative or other reasons.
27. Candidates will be considered on merit, but final decision will be taken by the administration.
28. If a candidate submits any documents after the prescribed time, those documents will not be considered, and his application will be deemed ineligible.
